name of an acceptable substitute at the receiving station.

When communication with the number required is established but further efforts to complete the call are abandoned, neither the particular person required nor an accepted substitute being obtainable, a "report charge" of £2 will be made in place of the normal charge. The caller will be notified of the impracticability of completing the call. When a " particular person" call matures, no " report charge " will be made.
