On the East, from Aylesbury southwards on the east side of the Great Western and London and North Eastern Railway to the point where that railway crosses the Lower Icknield Way near to Little Kimble; thence along the road from Stoke Mandeville through Princes Risborough to the point where that road meets the road from High Wycombe to West Wycombe; thence westwards along the road from High Wycombe through West Wycombe and Stokenchurch to the point where that road enters Aston Wood; thence south-westwards along the road past Hailey Wood to Nettlebed; thence along the road from Nettlebed to Henley-on-Thames to the point where that road is joined by the road from Marlow; thence in a south-easterly direction to the point where the road from Twyford to Henley-on-Thames meets the road from Maidenhead to Henley-on-Thames; thence eastwards along the last-named road to the point where that road joins the road from Maidenhead to Twyford; thence southwards along the road through White Waltham and Touchen-end to Winkfield; thence southwards along the road through Winkfield Row to the point north of Stella Lodge where that road meets the road from Ascot to Wokingham:

On the South, from the point north of Stella Lodge on the road from Ascot to Wokingham westwards along that road through Bracknell to the point in Wokingham where that road meets the road from Sandhurst; thence north of the road from Wokingham to Reading to the point where that road crosses the Southern Railway; thence along that railway and east of Reading to the River Thames; thence along the River Thames and along the Great Western Railway to Pangbourne; thence along the road through Yattendon and past Copyhold Farm to the point near to Chieveley where that road meets the road from Newbury to Abingdon:

On the West, from the point near to Chieveley northwards along the road from Newbury to Abingdon through East Ilsley, Steventon and Drayton to Abingdon; thence along the River Thames to Oxford; thence along the River Cherwell to Islip:

SECOND SCHEDULE.

All that area of land comprising a portion of the County of Kent lying within a line drawn as follows, including, where any road is named as a boundary, the said road:—

On the North, from Whitstable eastwards along the coast to Reculver:

On the East, from Reculver in a south-easterly direction along an imaginary line drawn from Reculver directly through Sarre to the Southern Railway; thence along the railway to Westbere; thence south-eastwards to Elbridge House; thence along the road from Elbridge House through Littlebourne to the road from Canterbury to Deal; thence along the said road through Sandwich to Deal; thence along the coast to Dover:

On the South, from Dover along the coast through Folkestone and Sandgate to the Royal Military Canal near to Hythe; thence along the said Canal to the point near to Warehorne where the Southern Railway crosses the Canal:

On the West, from the point near to Warehorne where the Southern Railway crosses the Royal Military Canal northwards along the railway through Ashford, Chilham and Canterbury to Whitstable:

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation bearing date the 5th day of May, 1927, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Barnabas, New Whittington, situate in the Parish of Whittington, in the County of Derby and in the Diocese of Southwell:

“ Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Barnabas, New Whittington, situate as aforesaid:

“ Now, therefore, with the consent of the Right Reverend Bernard Oliver Francis, Bishop of Southwell (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parish of Whittington which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Barnabas, New Whittington, situate as aforesaid, and that the same should be named ‘ The District Chapelry of Saint Barnabas, New Whittington.’
