PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE WORKERS.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 21st April, 1927, the Trade Board established under the Trade Boards Act, 1918, for the Sack and Bag Trade in Great Britain, as specified in the Trade Boards (Sack and Bag) Order, 1920, hereby give notice that they pro-pose to vary the Minimum Rates of Wages for certain classes of Male Workers as shewn in the Schedule set out below.
