## UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

Notice is hereby given under Section 45 of the Schedule to the above mentioned Act of the submission to His Majesty in Council of Statutes made by the University of Cambridge Commissioners for the University of Cambridge amending Statute B Chapter III Sections 7 and 8, Statute D Chapter XIV, and Statute T; and adding to the existing Statutes of Christ's College, Clare College, Corpus Christi College, Downing College, Emmanuel College, Gonville and Caius College, Jesus College, King's College, Magdalene College, Pembroke College, Peterhouse, Queens' College, St. Catharine's College, St. John's College, Selwyn College, Sidney Sussex College, Trinity College, and Trinity Hall, a new Statute relative to benefactions and endowments

WHEREAS by the Charter of Incorporation of the Imperial College of Science and Technology it is provided that six

members of the Governing Body of the said College shall be appointed by His Majesty:

And whereas under the provisions of the said Charter the term of Office of three of the members appointed by His Majesty, viz., Sir Henry Birchenough, Bt., K.C.M.G., Sir Donald MacAlister, Bt., K.C.B., and Sir Otto Beit, Bt., K.C.M.G., will expire on the 31st day of May, 1927, and it is expedient that the last two named should be re-appointed for a further term of Office:

And whereas the said Sir Henry Birchenough, Bt., K.C.M.G., does not desire to be re-appointed, and it is necessary that a new member should be appointed in his place:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that Sir Donald MacAlister, Bt., K.C.B., and Sir Otto Beit, Bt., K.C.M.G., be re-appointed as members of the Governing Body of the Imperial College of Science and Technology for a further term of four years from the 1st day of June, 1927, and that the Lord Rayleigh, Sc.D., F.R.S., be appointed to be a member of the said Governing Body for a term of four years from the 1st day of June, 1927.
