"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 26th day of October, 1860, and published in the London Gazette on the 30th day of the same month a District Chapelry was assigned to the consecrated Church of Saint Philip, situate at Girlington, in the Parish of Bradford, in the said County of York and at that time in the Diocese of Ripon but now in the said Diocese of Bradford, and the said District Chapelry was named 'The District Chapelry of Saint Philip, Girlington':

"And whereas by the authority of another Order of Her said late Majesty in Council bearing date the 8th day of February, 1890, and published in the London Gazette on the 11th day of the same month a District Chapelry was assigned to the consecrated Church of Saint Peter, Allerton, situate in the District Parish of Wilsden cum Allerton, in the said County of York and at that time in the said Diocese of Ripon but now in the said Diocese of Bradford, and the said District Chapelry was named 'The District Chapelry of Saint Peter, Allerton':

"And whereas the said District Chapelry of Saint Philip, Girlington, and the said District Chapelry of Saint Peter, Allerton, have, under the provisions of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, become New Parishes of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas by the authority of an Order of Your Majesty in Council bearing date the 21st day of March, 1924, and published in the London Gazette on the same day portions of the said New Parish of Saint Philip, Girlington, and of the said New Parish of Saint Peter, Allerton, were constituted a separate District for spiritual purposes and the said District was named 'The District of Saint Saviour, Bradford':

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parish of Saint Philip, Girlington, the said New Parish of Saint Peter, Allerton, and the said District of Saint Saviour, Bradford, should be altered in the manner which is hereinafter mentioned:

" Now, therefore, with the consent of the Right Reverend Arthur, Bishop of Bradford (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint Philip, Girlington, the said New Parish of Saint Peter, Allerton, and the said District of Saint Saviour, Bradford, shall be altered so that, first all those portions of the said New Parish of Saint Philip, Girlington, and of the said New Parish of Saint Peter, Allerton, which are described in the First Schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such New Parishes and shall be annexed to and shall in future form part of the said District of Saint Saviour, Bradford; and, secondly, all that portion of the said District of Saint Saviour, Bradford, which is described in the Second Schedule hereunder written and is delineated and set forth upon the said Map or plan hereunto annexed and is thereon coloured green shall be dissevered from such District and shall be annexed to and shall in future form part of the said New Parish of Saint Peter, Allerton.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme or Representation has reference.

## " THE FIRST SCHEDULE.

"The territory to be annexed to the District of Saint Saviour, Bradford, in the County of York and in the Diocese of Bradford, being:—

"I. All those contiguous portions of the New Parish of Saint Philip, Girlington, and of the New Parish of Saint Peter, Allerton, both in the said County and Diocese, which, taken together, are bounded upon the south and upon the south east by the said District of Saint Saviour, Bradford, and upon the remaining sides, that is to say, upon the north east, upon the north, and upon the west, by an imaginary line commencing upon the boundary which divides the said District of Saint Saviour, Bradford, from the said New Parish of Saint Philip, Girlington, at the junction of Crow Tree Lane with Allerton Road, and extending thence first north westward and then westward along the middle of Allerton Road for a distance of 291 chains or thereabouts to its junction with the new road called Rhodesway, and extending thence southward along the middle of the said new road (thereby crossing the boundary which divides the said New Parish of Saint Philip, Girlington, from the said New Parish of Saint Peter, Allerton) for a distance of 331 chains or thereabouts to the boundary which divides the said New Parish of Saint Peter, Allerton, from the said District of Saint Saviour, Bradford.

"II. And also all that other portion of the said New Parish of Saint Peter, Allerton, which is bounded upon the south by the New Parish of Saint James, Thornton, in the said County and Diocese, upon the east by the said District of Saint Saviour, Bradford, and upon the remaining side, that is to say, upon the north west, by an imaginary line commencing upon the boundary which divides the said District of Saint Saviour, Bradford, from the said New Parish of Saint Peter, Allerton, at a point in the middle of the said new road called Rhodesway opposite to the middle of the footpath leading past Oak Cottages into Chapel Lane, and extending thence south westward along the middle of the said new road for a distance of 3 chains or thereabouts to its junction with Thornton Road, and extending thence south westward along the middle of Thornton Road for a distance of 17 chains or
