TOOTING GRAVENEY.-Forthwith and entirely in the Parish Church of Saint Nicholas, Tooting Graveney, in the Metropolitan Borough of Wandsworth, and, except as hereinafter provided, in the Parish Churchyard as it existed prior to 1857. Provided that—(a) In any vault or walled grave now existing in the said portion of the Churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented. (b) In any earthen grave now existing in the said portion of the Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 8th day of August next.

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within the Parish affected by such Representation one month before the said 8th day of August.

(1) Thomas Edward Jarvis, in the grave of his wife.

(2) Mary Stevens, in the grave of her husband.

Subject, in each case, to the condition that the coffin be separately enclosed by stonework or brickwork properly cemented.

(b) In the said Churchyard, the burial may be allowed of the bodies of Ellen Dale, Thomas Richardson, and Caroline Jane Richardson at their decease, for whom grave spaces have been reserved and appropriated as a burial place, with the exclusive right of burial therein, subject in each case to the same condition as that above-mentioned.

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 8th day of August next.
