The following Statute made by the Governing Body of The Queen's College, Oxford, on the 18th day of May, 1927, and sealed on the 13th day of June, 1927, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

##### AMENDMENT TO STATUTE.

Whereas it is expedient to provide that the Reverend Edward Mewburn Walker Master of Arts be deemed to be qualified for election to the office of Provost even though the date of election may be subsequent to the last day of July next after he has attained the age of seventy years;

The College, under and by virtue of the powers conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of any other power enabling it, at a Stated General Meeting of the Governing Body, after due notice, held upon the eighteenth day of May, 1923, by the unanimous vote of the persons present and voting, made the following Amendment to a Statute made by the University of Oxford Commissioners for the Queen's College, Oxford, and ordered it to be submitted to His Majesty in Council, to be dealt with as provided by the said Act:

In Statute XXV.—Supplemental and Temporary Provisions, at the end of the Statute add the following new Clause:—

"12. Nothing in these Statutes shall be construed as precluding the election of the Reverend Edward Mewburn Walker, M.A., to the office of Provost, to hold that office until the last day of the month of July next following his attainment of the age of 75 years, provided that such election be made by a vote of not less than two-thirds of the members present and voting at the meeting duly summoned for the election of the Provost."
