WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 18th day of June, 1927, (C.W. 5232/27), in the words following, viz. :—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions, or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas Naval Observer Officers appointed in an advisory capacity to ships under construction are not eligible for Observers' Allowance under the conditions laid down in Your Order in Council bearing date the 26th day of April, 1920:

"And whereas we consider that such Officers, whose qualifications as Observers are the reason for their appointment, should receive some extra remuneration:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the payment, with effect from the 12th day of April, 1927, of a special allowance of 2s. 6d. a day to fully qualified Naval Observers appointed to ships prior to trials; payment of the allowance during periods of sickness to be at our discretion.

"The Lords Commissioners of Your Majesty's Treasury have signified Their concurrence in this proposal."

WHEREAS by Royal Proclamation made in pursuance of section 1 of the Royal and Parliamentary Titles Act, 1927 (G. 5. c. 4), His Majesty has appointed and declared, amongst other things, that henceforth, so far as conveniently may be, on all occasions and in all instruments wherein the style and titles appertaining to the Crown are used, the following alteration shall be made in the style and titles now appointed namely, for the words "the United Kingdom of Great Britain and Ireland and of," there shall be substituted the words "Great Britain, Ireland and":

And whereas it is provided by section 2 of the said Act that Parliament shall hereafter be known as and styled the Parliament of the United Kingdom of Great Britain and Northern Ireland, and that in every Act passed and public document issued after the passing of that Act the expression "United Kingdom" shall unless the context otherwise requires mean Great Britain and Northern Ireland:

And whereas it is provided by section 3 of the Crown Office Act, 1877 (40—1 V. c. 41), that His Majesty may, by Order in Council, make and when made from time to time revoke, add to or alter Rules prescribing the form in which documents to which that Act applies, are to be worded:

And whereas the provisions of Section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. The following Rule shall apply to any document of such a character or belonging to such a class as would, when this Order comes into operation, be required to be, or usually would be, authenticated by being passed under the Great Seal:—

RULE.

Where any of the expressions set out in the first column of the Schedule hereto occurs in the prescribed or customary form of any document to which this Rule applies, then the corresponding expression or one of the corresponding expressions set out in the second column of that Schedule may be substituted therefor, if the context so permits for the purpose of documents issued after this Rule comes into operation.
