Commissioners Measure, 1926, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for augmenting the incomes of the Archdeaconry of Colchester, the Archdeaconry of Southend and the Archdeaconry of West Ham, all in the Diocese of Chelmsford:

"Whereas it appears to us to be desirable that the incomes of the said Archdeaconry of Colchester, of the said Archdeaconry of Southend and of the said Archdeaconry of West Ham should be augmented in the manner which is hereinafter recommended and proposed:

"And whereas the grants hereinaiter recommended and proposed, together with any existing grant or grants now payable by us in augmentation of the incomes of the said Archdeaconries, will not have the effect of raising the annual incomes provided for such Archdeaconries out of the Common Fund created by the said Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, beyond the sum of £300 and will not raise the whole incomes of those Archdeaconries, including the income derived from any ecclesiastical office or preferment annexed thereto, beyond the sum of £1000 per annum:

sum of £1000 per annum: "And whereas there is at present payable to us, the said Ecclesiastical Commissioners, by the Archdeacon for the time being of the said Archdeaconry of Colchester an annual sum of £5 in respect of the annual tenths formerly payable to the Bishop of London, and we have agreed to make a grant of such annual tenths in augmentation of the income of the said Archdeaconry:

Archdeaconry: "Now, therefore, we, the said Ecclesiastical Commissioners, with the consent of the Right Reverend Guy, Bishop of Chelmsford (testified by his having signed and sealed this Scheme), humbly recommend and propose that, subject as in hereinafter mentioned, we, the said Ecclesiastical Commissioners, be authorised to pay out of the said Common Fund by equal quarterly payments on the first day of January, the first day of April, the first day of July, and the first day of October, or on such other quarterly days as the payments now made by us, the said Ecclesiastical Commissioners, in respect of the incomes of the respective Archdeaconries are usually made in every year, (first) to the Archdeacon of the said Archdeaconry of Colchester and to his successors in the same Archdeaconry a yearly sum of £295, (secondly) to the Archdeacon of the said Archdeaconry of Southend and to his successors in the same Archdeaconry a further yearly sum of £100, and (thirdly) to the Archdeacon of the said Archdeaconry of West Ham and to his successors in the same Archdeaconry a further yearly sum of £160, such yearly sums to take effect and be calculated as from the 1st day of January, 1927. Provided always that before any payment in respect of any of the said yearly sums shall be made by us we shall require to be satisfied that the Archdeacon who applies for the same has during the previous 12 calendar months complied with the conditions as to residence which for the time being are required by law.

"And we further recommend and propose that the said annual tenths amounting to £5 payable to us by the Archdeacon of the Archdeaconry of Colchester commencing with the yearly payment of those tenths due on Christ-

mas Day, 1927, shall for ever cease to be payable. "And we further recommend and propose

"" And we further recommend and propose that procurations, synodals, visitation fees and induction fees or any of these fees or payments shall no longer be receivable by the Archdeacons of the said Archdeaconries, and all such fees or payments shall accordingly cease to be payable to the said Archdeacons.

"And we further recommend and propose that whenever any Archdeacon who may be entitled to receive one of the said yearly sums of £295, £100 and £160 hereinbefore recommended to be paid to the said Archdeacon of Colchester, the said Archdeacon of Southend and the said Archdeacon of West Ham respectively shall resign or otherwise avoid his Archdeaconry, such yearly sum shall be apportionable between such Archdeacon or his representatives (as the case may be) and the Archdeaconry.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts and Measure, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Chelmsford.
