

day of January, the first day of April, the first day of July, and the first day of October, or on such other quarterly days as the payments now made by us, the said Ecclesiastical Commissioners, in respect of the income of the said Archdeaconry are usually made in every year to the Archdeacon of the said Archdeaconry of Warrington and to his successors in the same Archdeaconry a further yearly sum of £100, such yearly sum to take effect and be calculated as from the 1st day of January, 1927. Provided always that before any payment in respect of the said yearly sum of £100 shall be made by us we shall require to be satisfied that the Archdeacon who applies for the same has during the previous 12 calendar months complied with the conditions as to residence which for the time being are required by law.

"And we further recommend and propose that procurations, synodals, visitation fees and induction fees or any of these fees or payments shall no longer be receivable by the Archdeacon of the said Archdeaconry, and all such fees or payments shall accordingly cease to be payable to the said Archdeacon.

"And we further recommend and propose that whenever any Archdeacon who may be entitled to receive the said yearly sum of £100 hereinbefore recommended to be paid to the said Archdeacon of Warrington shall resign or otherwise avoid his Archdeaconry, such yearly sum shall be apportionable between such Archdeacon or his representatives (as the case may be) and the Archdeacon who shall next be collated to the same Archdeaconry.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts and Measure, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Liverpool.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th

and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 23rd day of June, 1927, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of an alternate right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of New Romney with Hope, in the County of Kent and in the Diocese of Canterbury:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of New Romney with Hope is vested alternately in Your Majesty, Your Heirs and Successors (being exercisable on behalf of Your Majesty by the Lord High Chancellor of Great Britain for the time being) and in the Reverend Hugh George South, of The Vicarage, Eastry, in the said County of Kent, Clerk in Holy Orders:

"And whereas the said Hugh George South is desirous that the whole of the said alternate right of Patronage of and presentation to the said Benefice of New Romney with Hope, now vested in him as aforesaid, should be transferred to and be vested in the Archbishop of Canterbury for the time being:

"And whereas the Right Honourable and Most Reverend Randall Thomas, now Archbishop of Canterbury, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said Randall Thomas, Archbishop of Canterbury, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of New Romney with Hope which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the Cure of Souls in the Parishes or Districts in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parishes of New Romney and Hope:

"Now, therefore, with the consent of the said Hugh George South (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Randall Thomas, Archbishop of Canterbury (in testimony whereof he has signed this Scheme and sealed the same with his Archbishopial Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day
