**BRIGHTON.**

Whereas the Mayor, Aldermen and Burgesses of the Borough of Brighton (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875 :—

(1) To amend the Brighton Hove and Preston Constant Service Waterworks Act, 1854, the Shoreham and District Waterworks Act, 1870, the Brighton Corporation Water Act, 1896, the Brighton Order, 1926, and any other Local Act or Order regulating the charges to be made for a supply of water by the Corporation, and the Brighton and Hove (Outfall Sewers) Order, 1924, so as to provide that in the financial year commencing on the first day of April, 1928, (a) the rateable values of existing hereditaments in any area which is within the limits of the Corporation's waterworks undertaking or the district of the Brighton Intercepting and Outfall Sewers Board and in which the new Valuation List becomes operative on the first day of April, 1928, shall for the purposes of calculating water charges and contributions to the expenses of the Sewers Board be deemed to be the rateable values in force on the thirty-first day of March, 1928, and
