MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport after the expiration of at least forty days from this date in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act to make regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Routes Nos. 134 and 494) Provisional Regulations, 1927, to come into operation forthwith as provisional regulations to continue in force until regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for certain additional omnibus services in the Croydon area.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 10TH OCTOBER, 1927.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power

enabling him in this behalf, hereby orders as follows:—

1. Notwithstanding anything contained in Chapter 6 (Protection of Animals) of the Foreign Animals Order of 1910, and in Part VII (Protection of Animals) of the Importation of Canadian Cattle Order of 1923, animals shall not be carried on a weather deck of any vessel of the flush or spar deck type unless such deck is completely covered in to the satisfaction of the Minister.

2. This Order shall come into operation on the first day of November, nineteen hundred and twenty-seven, and shall cease to operate on the first day of April, nineteen hundred and twenty-eight.

3. This Order shall be read with the Orders mentioned in Article 1 hereof.
