I, WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT Standings for Hackney Carriages at the following places, and do make the following Regulations with regard to the Boundaries for the same, viz. :-

22nd September, 1927:—

APPOINTMENTS.

Αт SHAFTESBURY AVENUE, W.

Twenty-three Hackney Carriages in eight portions:

First Portion.—One carriage in centre of roadway, to stand immediately North of refuge opposite the Trocadero

Second Portion.—Two carriages in centre of roadway, commencing opposite entrance to No. 28, Shaftesbury Avenue and extending Northwards as far as necessary for two

Third Portion.—One carriage in centre of roadway, to

stand immediately South of refuge at Rupert Street.

Fourth Portion.—Three carriages in centre of roadway, commencing at a point opposite the Southern building line of the Globe Theatre and extending Northward as far as necessary for three carriages.

Fifth Portion.—Two carriages in centre of roadway, commencing at a point 12 yards South of refuge South of Wardour Street and extending Northward as far as necessary

for two carriages.

Sixth Portion.—Three carriages in centre of roadway, commencing opposite the entrance to No. 53, Shaftesbury Avenue and extending Northward as far as necessary for three carriages.

Seventh Portion.—Three carriages in centre of roadway, commencing opposite the entrance to No. 67, Shaftesbury Avenue and extending Northward to South end of refuge.

Eighth Portion.—Eight carriages in centre of roadway,

commencing at a point two yards from crossing North of Dean Street and extending Northward as far as necessary for eight carriages.

Front of vehicles on each portion toward the South.

The first portion of the Standing to be fed exclusively by carriages from the second portion, the second from the third, the third from the fourth, the fourth from the fifth, the fifth from the sixth, the sixth from the seventh, and the seventh from the eighth portion.

NOTE.—This Standing will not be available between the hours of 10.30 p.m. and 11.30 p.m. on any day, excepting Sunday.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
