

ground thereto belonging and that the fees for the same and for other Ecclesiastical Offices and of Ecclesiastical dues and offerings arising from and in respect of the said portions of the said parishes of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively so to be annexed to the said parish of Brothertoft and usually payable to the Incumbent of a Benefice shall belong and be paid to the Incumbent of the said parish and Benefice of Brothertoft.

"That the inhabitants of the said portions of the said parishes of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively shall be exonerated from all liability to repair the Churches of the respective parishes of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively or any other Church or Chapel now or hereafter to be erected in the said last mentioned parishes respectively but shall be liable subject to the provisions of 'The Compulsory Church Rate Abolition Act, 1868,' to repair the said Church of Brothertoft.

"That the inhabitants of the said portions of the said parishes of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively shall be entitled to resort to and attend the said Church of Brothertoft as their parish Church and to be accommodated with sittings therein but shall not henceforth be entitled to any accommodation in the respective Churches of the said parishes of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively or in any Church or Chapel now or hereafter to be erected in the said last mentioned parishes respectively except nevertheless any person or persons (if any) possessing a legal right by faculty or otherwise to any pew or sitting in the said parish Churches of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively and who may not be willing to relinquish and give up the same.

"That nothing herein contained shall affect the endowments of the said Vicarage of Holland Fen the said Vicarage of Boston the said Rectory of Wyberton the said Vicarage of Frampton the said Vicarage of Kirton the said Vicarage of Swineshead or the said Vicarage of Wigtoft respectively or the rights of Patronage to any of the said Benefices of Holland Fen Boston Wyberton Frampton Kirton Swineshead and Wigtoft respectively."

"THE SCHEDULE TO WHICH THE ABOVE REPRESENTATION AND SCHEME HAVE REFERENCE.

"PART 1.

"Holland Fen.

"All that part of the parish of Holland Fen delineated on the said map hereto appended and thereon coloured yellow and which is bounded on the South by the Boston-Grantham and Sleaford Railway.

"On the West by the Ten foot drain.

"On the North by Gill Syke.

"On the East by Ferry Corner plots thence in a south-westerly direction to the North Forty foot drain at Hedgehog Bridge and thence by the North Forty foot drain and the Parliamentary County Division Boundary to Hubberts Bridge road.

"PART 2.

"Boston.

"All that part of the parish of Boston delineated on the said map hereto appended and thereon coloured brown and which is bounded on the East by the sewer which empties into the River Witham after passing through Shuff Fen and which crosses Punchbowl Lane, also by Punchbowl Lane for a distance of 5 chains also by Cross Drove.

"On the South by the Municipal Borough Boundary of Wyberton shewn on the 2nd Edition 1906 (scale 6" to the mile) Ordnance Survey Map.

"On the West by the Municipal Boundary.

"On the North by Cross Drove also by the Municipal Borough Boundary which divides Boston West from Kirton (Det. No. 3) on the Ordnance Survey Map 2nd Edition 1906 (6" to the mile) and also Frampton (Det. 1) on the same Map.

"PART 3.

"Wyberton.

"All that portion of the parish of Wyberton delineated on the said map hereto appended and thereon coloured purple and which is bounded on the West by the Langrick Road.

"On the South by the North Forty foot drain.

"On the East by the continuation of Cross Drove.

"On the North by the Parliamentary County Division Boundary dividing Wyberton from Boston and Brothertoft according to the Ordnance Survey Map 2nd Edition 1906 (6" to the mile).

"Also all that detached portion of the parish of Wyberton delineated on the said map hereto appended and thereon coloured purple and which is bounded on the West by Ferry Corner Plot (Det. No. 1).

"On the North by Langrick Parliamentary County Division and R.D. Boundary.

"On the East by Ferry Corner Plot (Det. No. 2) and Langrick Parliamentary County Division and R.D. Boundary.

"Also all that detached portion of the parish of Wyberton delineated on the said map hereto appended and thereon coloured purple and which is bounded on the West by the detached portion of Frampton (Det. No. 1) on the Ordnance Survey Map 1906 (2nd Edition) and on the East by the River Witham and Shuff Fen.

"PART 4.

"Frampton.

"All that part of the parish of Frampton delineated on the said map hereto appended and thereon coloured red and which is bounded on the South by Long Holt by the Kirton-Frampton boundary as in the Ordnance Survey Map 1902 (2nd Edition) which divides Bridge Angle from Bridge Piece also by the Old Hammond Beck and the Extraparochial piece of land known as 'The Friths.'

"On the West by the Kirton Holme Hubberts Bridge Langrick Road.

"On the North by the North Forty foot bank.
