

The maximum price now authorised in respect of the supply of gas by the Undertakers is 5s. Od. per 1,000 cubic feet and the price which the Undertakers have asked the Board of Trade to substitute for this price in accordance with paragraph (b) above is 1s. 6d. per therm.

It is also proposed that additional charges per therm, namely 3d., should be authorised in respect of gas supplied through a prepayment meter.
