ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 22ND NOVEMBER, 1927.)

FOOT-AND-MOUTH DISEASE (INFECTED
AREAS) ORDER OF 1927 (No. 52).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Further Contraction of Wiltshire Foot-and-Mouth Disease Infected Area.

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1927 (No. 46) as amended by the Foot-and-Mouth Disease (Infected Areas) Orders of 1927 (Nos. 47 and 49), shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the Schedule to the last mentioned Order.

(2) This Article shall come into operation on the twenty-seventh day of November, nineteen hundred and twenty-seven.

Release of Wiltshire Area from Restrictions.

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the fourth day of December, nineteen hundred and twenty-seven.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1927 (No. 52).

SCHEDULE.

Contracted Infected Area.

An Area comprising:—

In the county of Wiltshire

The borough of Swindon:

The parishes of Winterbourne Bassett, Broad Hinton, Broad Town, Clyffe Pypard, Wroughton, Stanton Fitzwarren and South Marston;

Such parts of the parishes of Highworth and Hannington as lie to the south of (*and excluding*) the following boundary namely:—

Commencing at the point where the Highworth-Shrivenham road crosses the River Cole near Friars Farm, thence in a generally north-westerly direction along the said road via Friars Hill, Swindon Street and Lechlade Road as far as the point where the road leading to Highworth railway station is met; thence westerly along the last mentioned road to the Highworth railway passenger station; thence continuing in a westerly direction along the Swindon-Highworth railway as far as Hannington Station; thence in a northerly direction along the road leading to Stapler's Lane, and along the latter lane, and Lawn Lane to the Hannington parish boundary;

So much of the parish of Blunsdon St. Andrew as is comprised within the boundary formed by the Highworth-Blunsdon St. Andrew road on the north and the Cricklade-Swindon road on the west (*excluding those roads*).

The parish of Stratton St. Margaret (*except that part which is comprised within the boundary formed on the east by the Cricklade-Swindon road and on the south by Whitworth Road and excluding those roads*);

So much of the parish of Rodbourne Cheney as lies to the south of the Lydiard Tregoze-Upper Stratton road;

So much of the parish of Lydiard Tregoze as lies to the east of the Lydiard Tregoze-Broad Hinton road, and also so much of the said parish as is comprised within the area formed on the north by the Swindon-Brinkworth road and on the west by Stoneover Lane (*excluding those roads*), and also including the detached part of that parish;

So much of the parish of Wootton Bassett as lies to the east and south of (*and excluding*) the following boundary, namely:—

Commencing at Stoneover Lane and following that lane in a southerly direction to its junction with the Wilts and Berks Canal, thence westerly along the said canal to the point where it is crossed by the Wootton Bassett-Clyffe Pypard road thence southerly along that road as far as the parish boundary at Breach Lane.
