Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

- (1) This Order may be cited as the West Ham Registration of Births, etc. (Alteration of Sub-districts) Order, 1927, and shall come into operation on the 1st day of December, 1927.
- (2) The part of High Street Ward of West Ham County Borough now included in the Plaistow Sub-district of West Ham Registration District shall be transferred to the Stratford Sub-district of the same Registration District.
- (3) The Registrar of the existing Stratford Sub-district shall be the Registrar of that Sub-district as extended by this Order.
