#### WEST SURREY WATER.

(Confirmation of acquisition of land, superannuation and other allowances; annual accounts; annual ordinary meetings instead of half-yearly; interim dividends; extension of limits of supply; incorporation, amendment and repeal of Acts etc.)

**N**OTICE is hereby given that the West Surrey Water Company, whose principal office is situate at 38, Parliament Street, Westminster, S.W. 1 (hereinafter called "the Company"), intend to apply to the Minister of Health on or before the 23rd day of December next under the Gas and Water Works Facilities Act 1870 and the Gas and Water Works Facilities (Amendment) Act, 1873, for a Provisional Order (hereinafter called "the Order") for all or some of the following purposes (that is to say):—

1. To sanction and confirm the acquisition by the Company of the land next hereinafter described and the expenditure of capital therefor and to empower the Company to retain hold and use the said lands namely:—

A piece of land situate in Weybridge Lane in the Parish of Walton-on-Thames in the County of Surrey comprising the Field or enclosure numbered 1009 on the <sup>2500</sup> Ordnance Map Edition 1914 Surrey Sheet XI—8 containing thirteen acres or thereabouts.

2. To enable the Company to make, continue and maintain on or in the said land or on any lands for the time being owned by them or as to which they have any necessary easements all such mains, pipes, channels, reservoirs, tanks, roads, buildings and other

machinery, works or apparatus, as may be necessary.

3. To empower the directors to make superannuation and other allowances to officers servants or employees of the Company etc.

4. To empower the Company to make up and balance their accounts annually instead of half yearly; to provide for the holding in each year of one instead of two ordinary meetings of the proprietors of the Company and to enable the Directors to pay interim dividends.

5. To extend the limits of the Company for the supply of water so as to include therein so much of the existing limits of supply of the South West Suburban Water Company as comprises the portion of the Parish of Laleham in the Rural District of Staines and County of Middlesex as is situate to the eastward of the centre line of the road leading from Chertsey to Littleton and to provide that such portion of the said Parish of Laleham shall be transferred to and form part of the limits within which the Company may supply water and that all powers duties and obligations of the South West Suburban Water Company with reference to the supply of water in such portion of the said Parish shall absolutely cease and determine.

6. To incorporate with or without modification all or some of the provisions of the Companies Clauses Consolidation Act 1845 and the Companies Clauses Act 1863 as amended by subsequent Acts the Water Works Clauses Acts 1847 and 1863 and the Gas and Water Works Facilities Acts 1870 and 1873, and any Acts amending those Acts respectively and to confer on the Company all necessary powers for the purposes aforesaid and other powers usually conferred upon water companies and to vary or extinguish all rights and privileges which would impede or interfere with such purposes and confer other rights and privileges.

7. To incorporate with the Order or apply thereto with or without amendment and to amend extend or repeal so far as may be necessary for the purposes of the Order all or some of the provisions of the West Surrey Water Acts 1869, 1877, 1888 and 1901 and any other Act or Acts or any Order or Orders relating to the Company or their undertaking or relating to any authority company, body or person with which the Company may be authorised to enter into any contract or arrangement, or any other Act or Order which would interfere with the objects of the Order.
