TRADE BOARDS ACTS, 1909 AND 1918.

TOBACCO TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE APPRENTICES IN THE CIGAR SECTION OF THE TRADE.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 21st April, 1927, the Tobacco Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY the Minimum Rates of Wages for Apprentices in the Cigar Section of the Trade, contained in the Trade Board's Notice N(12), by providing that the rates set out in Part I of the Notice N(12) shall only apply if certain conditions are complied with and by providing that, in the event of the period of apprenticeship being extended beyond five years in accordance with the proposed new conditions, the minimum rate applicable during the period of apprenticeship served after the expiration of five years from the date of commencement shall be the appropriate rate for an apprentice in the fifth year of apprenticeship.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 9th day of December, 1927. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Tobacco Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that Objections should state precisely and, so far as possible, with reasons, what is objected to.
