FOOT - AND - MOUTH DISEASE (IN-  
FECTED AREAS) ORDER OF 1927  
(No. 58).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Contraction of Birmingham Infected Area.*

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1927 (No. 57) shall be read and

have effect as if the Area described in the Schedule to this Order were excluded from and ceased to form part of the Foot-and-Mouth Disease Infected Area described in the Schedule to that Order.

*Revocation of Certain Order.*

2. The Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1927 (No. 2) is hereby revoked.

*Commencement and Short Title.*

3. This Order shall take immediate effect and may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1927 (No. 58).
