COAL MINES ACT, 1911.

RELIGHTING OF SAFETY LAMPS BELOWGROUND.

The Secretary for Mines gives notice that on the 9th day of December, 1927, he made, by Order under Section 86 of the Coal Mines Act, 1911, General Regulations amending Sections 33 and 34 of the Coal Mines Act, 1911, in regard to the unlocking, opening and relighting of safety lamps belowground.

On the same date he also made an Order under Sections 33 and 35 of the Coal Mines Act, 1911, and the foregoing Regulations, authorising and prescribing conditions for the use in mines under that Act of flame safety lamps fitted with self-contained relighting devices.

Both the Regulations, which may be cited the Coal Mines General Regulations 28 (Safety Lamps), 1927, and the Order, which may be cited as the Safety Lamps (Relighting) Order, 1927, come into force on the First day
