The effect of the amending Order of the 20th December, 1927, is to substitute a period of "ten years" for the period of "five years," in the provision cited above, in respect of the roads described in the Schedule hereto.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Release of Wiltshire Foot-and-Mouth Disease Infected Area from Restrictions.*

1. The Area No. 4 (a) described in the Schedule to the Foot-and-Mouth Disease (Infected Areas) Order of 1927 (No. 59) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the fifth day of January, nineteen hundred and twenty-eight.

*Short Title.*

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1927 (No. 67).

FOOT-AND-MOUTH DISEASE (INFECTED  
AREAS) ORDER OF 1927 (No. 66).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Declaration of Foot-and-Mouth Disease Infected Area.*

1. The Area described in the First Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

*Extension of certain Infected Area.*

2. The Foot-and-Mouth Disease (Infected Areas) Order of 1927 (No. 62) as amended by the Foot-and-Mouth Disease (Infected Areas) Orders of 1927 (Nos. 63 and 64) shall be read and have effect as if the Area described in the Second Schedule to this Order were included in and formed part of the Foot-and-Mouth Disease Infected Area described in the First Schedule to that Order.

*Movement of Animals (Fat or Store) into certain Infected Area from Controlled Area.*

3. Article 1 of the Midlands (Foot-and-Mouth Disease) Order of 1927 (No. 3) shall be read and have effect as if it applied to the movement of animals (fat or store) into any Infected Area declared by this Order from premises in the Controlled Area referred to in the first-mentioned Order.

*Short Title*

4. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1927 (No. 66).
