DARLINGTON.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Darlington (hereinafter called the Corporation), being the Urban Sanitary Authority for the County Borough of Darlington, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Darlington Extension and Improvement Act, 1872, as amended by certain Provisional Orders confirmed by Parliament and including the Darlington Order, 1902, the Darlington Order, 1912, and the Darlington Order, 1923, so as :--

(1) To empower the Corporation, with the sanction of the Minister of Health, to borrow such further sums not exceeding in the whole the sum of £150,000 as may be necessary for the purposes of the water undertaking of the Corporation.

(2) To authorise the Corporation to form and maintain a Reserve Fund in respect of the water undertaking.

(3) To make further provision for regulating the water undertaking of the Corporation and in particular:---

(a) To provide that the Corporation shall not be bound to supply with water otherwise than by measure (i) any building used by an occupier as a dwelling-
