

Unemployment Insurance Act, 1920, namely, whether the employment of persons in the following circumstances is, or is not, employment within the meaning of the Unemployment Insurance Act, 1920:—

Employment as a domestic servant by the proprietor and for the purposes of a hostel for students attending a High School for Girls which is primarily a day school.

Pupils and students, however, attending the High School may be received in recognised boarding houses or hostels the proprietors of which comply with certain regulations of the School Authorities.

The proprietor of such a boarding house or hostel is financially independent of the school and may or may not be a member of the teaching staff of the school.

Under the Rules of the Supreme Court Order LV.B, Rule 28, any person who claims to be affected by the decisions to be given in the above mentioned cases may apply to the Judge for leave to intervene.

The cases have been set down in the High Court and will be heard in the near future.

TRADE BOARDS ACTS, 1909 AND 1918.

VARIATION OF OVERTIME RATES OF WAGES IN THE LAUNDRY TRADE.

The Laundry Trade Board (Great Britain) have issued Notices dated 9th March, 1928, (1) for the areas of Cornwall and the North of Scotland, and (2) for the rest of Great Britain, setting out the Overtime Rates of Wages as varied by them and confirmed by Order of the Minister of Labour, to take effect as from 12th March, 1928, together with all minimum rates previously in operation which are unaffected by the present variation.
