

EXTRADITION TREATY OF JULY 22ND.
1926, BETWEEN THE UNITED KING-
DOM AND ALBANIA.

Foreign Office,
8th March, 1928.

Whereas by the "Albania (Extradition) Order in Council, 1927," it was provided that from and after the 11th day of July, 1927, the Extradition Acts, 1870 to 1906, should apply in the case of the Albanian Republic under and in accordance with the Treaty concluded on the 22nd day of July, 1926, between His Majesty and the President of the Albanian Republic:

And whereas it was further provided by the said Order in Council that the operation of the said Acts should be and remain suspended within the self-governing Dominions hereinafter named, that is to say, the Commonwealth of Australia (including for this purpose Papua and Norfolk Island), the Dominion of New Zealand, the Union of South Africa, the Irish Free State and Newfoundland, and India, until notification should have been made in the London Gazette that the Treaty had been made applicable thereto, and that on such notification being made in respect of any such Dominion or India the said Acts should apply in such Dominion or India in the case of the Albanian Republic, under and in accordance with the said Treaty as from the date of the said notification:

Now, therefore, it is hereby notified that the said Treaty has been made applicable to the Commonwealth of Australia (including for this purpose Papua and Norfolk Island), the Dominion of New Zealand, the Union of South Africa and Newfoundland, and India, as and from the present date, viz.:—the 8th day of March, 1928.

Stephenson & Milne, St. Johns Works, Kirkstall Lane, Leeds, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours and facilities for obtaining meals at the works shall be provided.
