Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

(1) This Order may be cited as the Narberth Registration of Births etc. (Alteration of sub-districts) Order, 1928, and shall come into operation on the 1st day of April, 1928;

(2) The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament;

. (3) The Narberth Sub-district of Narberth Registration District shall cease to exist and its constituent Civil Parishes shall be apportioned as follows:—

(a) The Civil Parishes of Amroth, Crinow, Crunwear, Cyffic, Eglwys Cymmyn, Lampeter Velfrey, Ludchurch, Marros, Narberth, Narberth North and Pendine, shall be added to and form part of the Begelly Sub-district of Narberth Registration District.

(b) The Civil Parishes of Castelldwyran, Henllan Amgoed, Llanddewi Velfrey, Llanfallteg East, Llanfallteg West, Llangan East, and Llangan West, shall be added to and form part of the Llanboidy Sub-district of the same Registration District. (4) The Sub-district of Begelly as extended by this Order shall be renamed the Narberth Sub-district.

(5) The Registrars of the existing subdistricts of Begelly and Llanboidy shall respectively be the Registrars of these subdistricts as extended by this Order.
