WEST DERBYSHIRE ELECTRICITY.

(Application for Special Order under the Electricity (Supply) Acts, 1882 to 1926.)

NOTICE is hereby given, that application has been made by the Derbyshire and Nottinghamshire Electric Power Company (hereinafter called "the Company"), whose principal office is at 66, Queen Street, in the city of London, to the Electricity Commissioners for a Special Order under the Electricity (Supply) Acts, 1882 to 1926, for the following amongst other purposes (that is to say):—

1. To authorise the Company to supply and distribute electricity for all public and private purposes, as defined by the above Acts, within—

The Urban District of Bonsall.

The Rural District of Ashbourne (except the Parishes of Glifton and Compton Edlaston and Wyaston, Mapleton, Middleton by Wirksworth, Offcote and Underwood, Osmaston, Snelston and Sturston).
