

Benefice; and if neither of the said two Benefices be then vacant then the said union shall take effect on the next avoidance of either of the said two Benefices if the Incumbent at that time of the other of the said two Benefices shall consent to become the first Incumbent of the United Benefice, but if he shall not so consent then the said union shall take effect immediately upon the next vacancy of his Benefice and the then Incumbent (if any) of the other of the said two Benefices shall become the first Incumbent of the United Benefice.

" 3. That at any time and from time to time after the Union has taken effect the Incumbent of the United Benefice shall employ such clerical or lay assistance in the performance of the duties of the United Benefice as the Bishop may require and towards the remuneration of clergy or lay workers so required to be employed the Incumbent of the United Benefice shall be liable to provide out of the income of the United Benefice such sum as may be necessary not exceeding the sum of £150 in any one year.

" 4. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Alton Barnes with Alton Priors shall become and be the house of residence for the Incumbent of the United Benefice and so soon as conveniently may be the Parsonage House at present belonging to the said Benefice of Stanton Saint Bernard and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us the said Ecclesiastical Commissioners at such time or times and in such manner in all respects as to us shall seem expedient and that the net proceeds of such sale shall be held and invested by us, the said Ecclesiastical Commissioners, for the benefit of the Benefice of Warminster situate in the said Diocese of Salisbury.

" 5. That after the said union has taken effect the course and succession in which the respective Patrons shall present or nominate to the United Benefice from time to time as the same shall become vacant shall be as follows, that is to say, that in every series of three successive turns of presentation or nomination to be made to the United Benefice after the union (a) if upon the union taking effect an Incumbent of the said Benefice of Stanton Saint Bernard shall become the first Incumbent of the United Benefice under any of the provisions of Clause 2 of this Scheme, then the Patrons of the said Benefice of Alton Barnes with Alton Priors shall have the first turn and the Patron of the said Benefice of Stanton Saint Bernard shall have the second and third turns but (b) if upon the union taking effect an Incumbent of the said Benefice of Stanton Saint Bernard shall not become the first Incumbent of the United Benefice under any of the provisions of Clause 2 of this Scheme, then the Patron of the said Benefice of Stanton Saint Bernard shall have the first and the third turns and the Patrons of the said Benefice of Alton Barnes with Alton Priors shall have the second turn.

" 6. That with the consent of the Patron of the said Benefice of Wilcot namely Doris Mary Irwin Montagu, wife of George Edward

Stirling Montagu, of Wilcot, in the said County of Wilts, Esquire (testified by her signing this Scheme), with the consent of the Reverend Percy Augustus Nash, now Incumbent of the said Benefice of Wilcot (testified by his signing this Scheme) with the consent of the Patrons of the said Benefice of Woodborough namely the Dean and Chapter of the Cathedral Church of the Blessed Virgin Mary at Salisbury (in testimony whereof they have caused their Common or Capitular Seal to be affixed to this Scheme) and with the consent of the Reverend Thomas Haworth Jervis, now Incumbent of the said Benefice of Woodborough (testified by his signing this Scheme), upon the union taking effect (A) a portion of the Parish of Alton Priors, that is to say the Hamlet of West Stowell or so much thereof as is delineated and set forth upon the Map or Plan hereto annexed and thereon coloured pink shall be severed from the said Parish of Alton Priors and Benefice of Alton Barnes with Alton Priors and shall be transferred and annexed for all ecclesiastical purposes to the said Parish and Benefice of Wilcot and (B) a portion of the Parish of Woodborough, that is to say, the Hamlet of Honey Street, or so much thereof as is delineated and set forth upon the said Map or Plan and thereon coloured green shall be severed from the said Parish of Woodborough and shall be transferred and annexed for all ecclesiastical purposes to the Parish of Alton Barnes.

" 7. That upon the union taking effect there shall be transferred and annexed to the said Benefice of Wilcot (a) the Modus of £5 6s. 0d. arising within the said Parish of Alton Priors and at present payable to the Incumbent of the said Benefice of Alton Barnes with Alton Priors and (b) a sum of £1,117 10s. 0d. Four pounds per cent. per annum Funding Stock (1960-1990) being part of a larger sum of such Stock at present held by us the said Ecclesiastical Commissioners for England for the benefit of the said Benefice of Stanton Saint Bernard.

" Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Salisbury has been duly given
