SWANSEA AND MERTHYR TYDFIL.

Whereas the Mayor, Aldermen, and Burgesses of the respective boroughs of Swansea and Merthyr Tydfil (hereinafter referred to as the Corporations) being the Urban Sanitary Authorities for the said Boroughs, have made applications to the Minister of Health for the issue of a Provisional Order under Sections 297 and 308 of the Public Health Act, 1875, partially to repeal, alter or amend the Swansea Corporation Act, 1912, so as:—

(1) To enable the Swansea Corporation with the sanction of the Minister of Health, to borrow the whole of such further moneys as may be required for completing the purchase of land for and the erection equipment and furnishing of the Joint Mental Hospital for the Boroughs of Swansea and Merthyr Tydfil at Cefn Coed, Cockett, Swansea, and for anything incidental thereto;

(2) To repeal wholly or in part the borrowing powers conferred upon the Merthyr Tydfil Corporation by the said Local Act or to transfer the same to the Swansea Corporation and to make provision with regard to any loans raised by the Merthyr Tydfil Corporation thereunder or the transferring of such loans if needs be to the Swansea Corporation;

(3) To enable the Corporations to enter into agreements or to vary any agreements between them relating to the said Mental Hospital subject to the approval of or in accordance with the directions of the Board of Control or the Minister of Health;

(4) To enable and require the Merthyr Tydfil Corporation to make annual payments in respect of the provision and maintenance of the said Mental Hospital as may be agreed between the Corporations or as may be prescribed by the proposed Provisional Order;

(5) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Boroughs of Swansea and Merthyr Tydfil as may be necessary or desirable:

MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport, after the expiration of at least forty days from this date, in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act, to make regulations amending the London Traffic (Restricted Streets) Regulations.

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Route No. 604) Provisional Regulations, 1928, to come into operation forthwith as provisional regulations to continue in force until regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for the transfer of certain omnibuses from Route No. 511 (Stratford Broadway and Chingford) to Route No. 604 (Stratford Broadway and Edmonton).
