affirming this Scheme the said Edwin Allwright shall with the consent of the said Bishop of Salisbury retire from the said Benefice of Tarrant Rushton with Tarrant Rawston in order that the union of that Benefice with the said Benefice of Tarrant Gunville as provided in Clause 3 of this Scheme may take immediate effect, then he shall be entitled to receive out of the annual income of the United Benefice and by way of compensation, an annual sum of £200 which annual sum shall commence as from the day upon which the said union shall take effect and shall be payable by equal quarterly payments in every year, the first quarterly payment becoming due at the end of three calendar months next after the day upon which the union shall take effect and the said annual sum shall be payable to the said Edwin Allwright during the remainder of his life subject, however, to the same conditions as to suspension, reduction and for-feiture, as a pension assigned to a retiring Incumbent under the provisions of the Incumbents' Resignation Acts, 1871 and 1887, and the provisions of those Acts as to recovery in case of non-payment and as to such conditions as aforesaid shall apply to the said annual sum and to the said Edwin Allwright as if the said annual sum were a pension awarded under the said Resignation Acts and the said Edwin Allwright had resigned the said Benefice of Tarrant Rushton with Tarrant Rawston under those Acts.

" 5. That upon the taking effect as aforesaid of the union of the said United Benefice of Tarrant Rushton with Tarrant Rawston with the said Benefice of Tarrant Gunville or with any United Benefice consisting of the said Benefice of Tarrant Gunville and any one or more of the said Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Keynston or Tarrant Crawford, the Parishes of the two Benefices of Tarrant Rushton and Tarrant Raws!on now forming the United Benefice of Tarrant Rushton with Tarrant Rawston shall also be united into one Parish for ecclesiastical purposes and for such other purposes as in the said Measure provided and upon the taking effect as aforesaid of the union of both of the said Benefices of Tarrant Keynston and Tarrant Crawford with the said Benefice of Tarrant Gunville or with any United Benefice consisting of the said Benefice of Tarrant Gunville and any one or more of the said Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston and Tarrant Rushton with Tarrant Rawston, the Parishes of the said Benefices of Tarrant Keynston and Tarrant Crawford shall also be united into one Parish for occlesiastical purposes and for such other purposes as in the said Measure provided.

"6. That in the event of any United Benefice formed in accordance with the provisions of Clause 3 of this Scheme and consisting of the said Benefice of Tarrant Gunville and one or more of the said five Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston, Tarrant Keynston and Tarrant Crawford falling vacant before all of the said five Benefices have been avoided by their present Incumbents such United Benefice shall be filled by an Incumbent appointed as hereinafter recommended and proposed, and the Incumbent so appointed if still Incumbent when the union recommended in Clause 1 of this Scheme shall take effect shall be the first Incumbent of the United Benefice of Tarrant Valley.

"7. That in the event as aforesaid of any United Benefice consisting of the said Benefice of Tarrant Gunville and any one or more of the said five Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston, Tarrant Keynston or Tarrant Crawford fulling vacant before all of the said five Benefices have been avoided by their present Incumbents the right to present or nominate an Incumbent to such United Benefice shall in the case of an United Benefice consisting of the said Benefice of Tarrant Gunville and the said Benefice of Tarrant Crawford belong wholly to the Patrons of the said Benefice of Tarrant Gunville and in the case of an United Bene-fice consisting of the said Benefice of Tarrant Gunville and any one of the said Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston, or Tarrant Keynston, shall belong to the Patron or Patrons of the two constituent Benefices in alternate turns and the first turn of presentation or nomination after the union shall belong to the Patron or Patrons of that one of the said Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston or Tarrant Keynston which shall so have become united with the said Benefice of Tarrant Gunville under the provisions of this Scheme, and in the case of an United Benefice consisting of the said Benefice of Tarrant Gunville and any two or more of the said five Benefices of Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston, Tarrant Keynston and Tar-rant Crawford, the right of presentation or nomination shall belong to the Patrons of the Benefices comprised in the union in a series of turns and the first turn to be exercised after the union and each succeeding turn respectively shall belong to that one or those of the Patrons whose last exercise of his or their right of Patronage in respect of any Benefice included in the United Benefice was most remote in point of time save that the Patron of the said Benefice of Tarrant Crawford shall have no share as such Patron or turn in the exercise of the Patronage of any such United Benefice.

"8. That the Church of the Parish of Tarrant Keynston shall be the Farish Church of the United Parish of Tarrant Keynston with Tarrant Crawford and the Church of the Parish of Tarrant Rushton shall be the Parish Church of the United Parish of Tarrant Rushton with Tarrant Rawston and that the Tables of Fees for the said Parishes of Tarrant Keynston and Tarrant Rushton shall (until revised or altered by proper authority) be the Tables of Fees for the United Parishes respectively.

"9. That upon the taking effect respectively of the unions (a) of the Parishes of Tarrant Keynston and Tarrant Crawford and (b) of the Parishes of Tarrant Rushton and Tarrant Rawston as provided in Clause 4 of this
