

Scheme the marriage registers in duplicate current at the Churches of Tarrant Crawford and Tarrant Rawston respectively shall be sent by the Incumbent of the United Benefice to the Registrar General to be closed officially.

" 10. That upon any of the said unions taking effect the Parsonage House at present belonging to the said Benefice of Tarrant Gunville shall become and be the house of residence for the Incumbent of the United Benefice and so soon as conveniently may be after the union of either of the said two Benefices of Tarrant Hinton and Tarrant Rushton with Tarrant Rawston with any other Benefice or Benefices as provided in Clause 3 or Clause 1 of this Scheme the Parsonage Houses at present belonging to the said two Benefices of Tarrant Hinton and Tarrant Rushton with Tarrant Rawston respectively and the sites and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall in each case be sold and disposed of by us the said Ecclesiastical Commissioners at such time or times and in such manner in all respects as to us shall seem expedient and that the net proceeds of such sales shall be held and invested by us for the benefit of the United Benefice of which the said Benefice of Tarrant Hinton or the said Benefice of Tarrant Rushton with Tarrant Rawston shall form part at the date of the sale, and ultimately for the benefit of the said United Benefice of Tarrant Valley.

" 11. That at any time and from time to time after the taking effect of the union of the said Benefice of Tarrant Gunville with another Benefice or other Benefices as provided in Clause 3 of this Scheme the Incumbent of the United Benefice shall employ such clerical or lay assistance in the performance of the duties of the United Benefice as the Bishop of Salisbury may require and towards the remuneration of clergy or lay workers so required to be employed the Incumbent of the United Benefice shall be liable to provide out of the income of the United Benefice such sum in any one year as the Bishop may determine.

" 12. That upon the union of all the said six Benefices taking effect as aforesaid two Curates shall be appointed to assist the Incumbent in the performance of the duties of the United Benefice, this recommendation and proposal being made to the intent that the Bishop of Salisbury shall have the power of requiring the appointment of two Curates in accordance with and subject to the conditions and provisions of Subsection (b) of Section 18 of the said Measure, provided that the stipend to be assigned by the Bishop to any Curate so required to be appointed may be such stipend as the Bishop may determine not exceeding £350, and in addition to the appointment of two Curates as aforesaid provision shall be made by the Incumbent of the United Benefice for obtaining the services of two Lay Readers or occasional clerical assistance and towards the remuneration of the two

Lay Readers or clergy so required to be employed the Incumbent of the United Benefice shall be liable to provide out of the income of the United Benefice such sum as may be necessary not exceeding the sum of £300 in any one year.

" 13. That after the union of all the said six Benefices has taken effect the course and succession in which the respective Patrons of the said Benefices of Tarrant Gunville, Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston and Tarrant Keynston shall present or nominate to the United Benefice from time to time as the same shall become vacant shall be as follows, that is to say, the first five turns of presentation after the union shall be exercised successively by the Patrons of the said Benefices of Tarrant Gunville, Tarrant Hinton, Tarrant Monkton with Tarrant Launceston, Tarrant Rushton with Tarrant Rawston and Tarrant Keynston in the order of remoteness of the then last presentations made by them respectively to the separate Benefices or to any United Benefice formed in accordance with the provisions of Clause 3 of this Scheme and succeeding turns in each series of five turns of presentation shall be exercised by the said Patrons in the same order.

" 14. That with the consent of the Right Honourable Claud Berkeley, Viscount Portman, Patron of the Benefice of Pimperne in the said County of Dorset and Diocese of Salisbury and with the consent of the Reverend Arthur Robert Dittmer, Incumbent of the said Benefice of Pimperne (in testimony whereof they have signed this Scheme), upon the taking effect of the union of the said Benefice of Tarrant Hinton with the said Benefice of Tarrant Gunville or with any United Benefice formed in accordance with the provisions of Clause 3 or Clause 1 of this Scheme a part of the Parish of the said Benefice of Tarrant Hinton shall be severed from such Parish and Benefice and shall be annexed to and form part of the Parish of the said Benefice of Pimperne for all ecclesiastical purposes namely all that part of the said Parish of Tarrant Hinton lying to the south west of such Parish and contiguous to the Parish of Pimperne, all which part is more particularly delineated and set forth upon the map or plan hereto annexed and thereon coloured blue and there shall be severed from the said Benefice of Tarrant Hinton and annexed to the said Benefice of Pimperne as an addition to the endowment thereof all those Tithe rentcharges commuted at £27 15s. 0d. arising within the area so recommended to be transferred as aforesaid, the particulars of which tithe rentcharges are set out in the Schedule hereto annexed.

" Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.
