of the river and adjacent to the Parish of Saint Andrew and All Saints be united to the latter Parish.

(2) That the southern portion of the Parish of Hallow which has a population connected by employment and otherwise with the City of Worcester, be united to the Parish of Saint Clement.

(3) That such part of the Parish of Saint John-in-Bedwardine, with an estimated population of 1,500, lying to the north of the Great Western Railway, be also united to the Parish of Saint Clement.

"4. The respective Patrons and Incumbents of the said Benefices are as follows :---

" 5. Pursuant to the directions contained in the 26th Section of the said Act of Parliament, I, the said Bishop, have drawn up a Scheme in writing annexed to this Representation describing the several areas or districts so as aforesaid proposed to be annexed to the said Parish of Saint Andrew and All Saints and Saint Clement respectively and the mode in which it appears to me that the alterations may best be effected and how the changes consequent thereon in respect to Ecclesiastical jurisdiction, Glebe Lands, Tithes, dues, rates and payments, and in respect to Patronage and rights to pews may be made with justice to all parties interested, and I do hereby submit the same to your Grace together with the Consents in writing of the said Patrons and Incumbents other than the Vicar of Saint John-in-Bedwardine and in case you shall on full consideration and enquiry be satisfied therewith I request that your Grace will be pleased to certify the same and the consent of the Patrons thereto to His Majesty in Council."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows :-

" SCHEME.

Parish of Saint Clement in the City and Diocese of Worcester and unite such district for Ecclesiastical purposes to the adjoining Parish of Saint Andrew and All Saints and which district is edged green and indicated by the letter 'A' on the annexed plan and is bounded by the River Severn and the parishes of Saint George, Saint Nicholas and Saint Andrew and All Saints. The remainder of the Parish of Saint Clement is edged pink and marked 'B' on the said plan.

"2. To separate a district from the Parish of Hallow and unite such district for Ecclesiastical purposes to the adjoining Parish of Saint Clement, and that such district shall consist of all that portion of the said Parish of Hallow which lies to the south of Martley Road and is bounded on the north by Martley Road on part of the east by the Parish of Saint Clement on the remainder of the east and on the south by the parish of Saint John-in-Bedwardine and on the west partly by Laugherne Brook and partly by the said Parish of Saint John and which district is edged yellow and indicated by the letter 'C ' on the said plan. "3. To separate a district from the

Parish of Saint John-in-Bedwardine and unite such district for Ecclesiastical purposes to the adjoining Parish of Saint Clement and that such district shall consist of that portion of the said Parish of Saint John-in-Bedwardine which lies to the north of the Great Western Railway and is bounded on the north and part of the east by the Parish of Hallow on the remainder of the east by the Parish of Saint Clement on the south by the Great Western Railway and on the west by Laugherne Brook aforesaid, and which district is edged blue and indicated by the letter 'D' on the said plan.

" If the Scheme is carried out the estimated population of the parishes on the western side of the river will be :----

" It is further proposed that each of the Incumbents of the respective Benefices of Saint Andrew and All Saints and Saint Clement in the City of Worcester shall have the sole and exclusive Cure of Souls within the limits of the said respective Districts so as aforesaid proposed to be annexed to the said respective Parishes and that all fees for Churchings, Marriages and Burials and other Ecclesiastical offices solemnized and performed at the Church and Churchyard of such Parishes in respect of the inhabitants of the District or Districts annexed thereto shall belong to and be received by such Incumbent.

" That the Inhabitants of the said respective Districts shall not in future be entitled to any accommodation in the respective Churches of the Parishes from which such Districts have been separated except in the case of any person or persons (if such there be) who now possess a legal right by faculty or otherwise to the exclusive use of any pew or sittings within the said Churches respectively and who may not be willing to relinquish the same.
