

(2) This Article shall come into operation on the second day of May, nineteen hundred and twenty-eight.

Release of Selston (Notts.) Area from Restrictions.

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the ninth day of May, nineteen hundred and twenty-eight.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1928 (No. 50).

SCHEDULE.

Contracted Infected Area.

An Area comprising:—

In the county of Nottingham.

The parishes of Brinsley, Selston and Felley; so much of the parish of Annesley as lies to the west of the road from Mansfield to Hucknall Torkard; and so much of the parish of Kirkby in Ashfield as is comprised within the following boundary, namely:—

Commencing at a point where the Hucknall Torkard—Mansfield main road crosses the southern boundary of Kirkby in Ashfield parish, thence following that road in a northerly direction to the point where it crosses the London and North Eastern Railway line (Great Central section) from Hucknall Torkard to Tibshelf; thence following that railway in a north-westerly direction to the point where it is crossed by the road from Kirkby in Ashfield to Pinxton; thence following that road in a westerly direction to the point where it crosses the county boundary.

In the county of Derby.

So much of the parish of Pinxton as lies to the south of the following boundary, namely:—

Commencing at a point where the Kirkby in Ashfield—Pinxton road leaves the county boundary near Pinxton Green, thence following that road in a westerly direction to the point where it meets the railway from Codnor Park to Pinxton (L.M. & S. Railway); thence westerly along that railway to the point where it crosses the south-western boundary of Pinxton parish.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Sheep Scab Order of 1928.

1. Part II (*Restriction on Movement of Sheep out of a Movement Area*) and Part III (*Double Dipping of Sheep in a Double Dipping Area*) of the Sheep Scab Order of 1928, hereinafter referred to as "the Principal Order," are hereby applied to the Area described in the Schedule hereto, which shall be a Movement Area and a Double Dipping Area for the purposes of that Order.

Period Prescribed as Double Dipping Period.

2. The dates between which all sheep in the Area described in the Schedule hereto are to be dipped within the Area by the owner or person in charge of the sheep under and in accordance with Part III of the Principal Order are hereby fixed to be the seventeenth day of November and the thirtieth day of December in each year.

Revocation of Certain Orders.

3. The Order of the Minister (No. 642) dated the nineteenth day of May, nineteen hundred and twenty-one, and the Order of the Minister (No. 4429) dated the nineteenth day of April, nineteen hundred and twenty-seven relating to the area described in the Schedule hereto are hereby revoked.
