Bishop of a Diocese within and of the Province of Canterbury, that the said Bishop is desirous of resigning his Bishopric, such resignation to take formal effect upon the 10th day of May, 1928, by reason that he is incapacitated by permanent physical infirmity from the due performance of his duties as Bishop:

And whereas His Majesty is satisfied of such incapacity and that the said Bishop has canonically resigned:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to declare, and it is hereby declared, that the said Bishopric of Southwell shall become vacant on the 10th day of May, 1928, and His Majesty by and with the like advice, is pleased to direct, and it is hereby directed, that this Order be forthwith registered by the Registrar of the Diocese of Southwell.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 2nd day of February, 1928, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 8th and 9th years of Her late Majesty Queen Victoria, Chapter 70, of the Act of the 14th and 15th years of Her said late Majesty, Chapter 97, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a Consolidated Chapelry to the consecrated Church of Saint Bartholomew, Derby, situate within the Parish of Osmaston, in the County of Derby and in the Diocese of Derby:

"Whereas at certain extremities of the said Parish of Osmaston, of the New Parish (sometime Particular District) of Saint James the Greater, Derby, and of the Parish of Normanton, both in the said County and Diocese, which said extremities lie contiguous one to another, and are described in the Schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such Parishes and New Parish:

Parishes and New Parish: "And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said Parish of Osmaston, of the said New Parish of Saint James the Greater, Derby, and of the said Parish of Normanton, should be formed into a Consolidated Chapelry for all Ecclesiastical purposes, and that the same should be assigned to the

said Church of Saint Bartholomew, Derby, situate as aforesaid:

" Now, therefore, with the consent of the Right Reverend Edmund Courtenay, Bishop of Derby, as such Bishop, with the consent of the Right Reverend Bernard Oliver Francis, Bishop of Southwell, as the Patron, in right of his See, as well of the Vicarage of the said Parish of Osmaston as of the Vicarage of the said New Parish of Saint James the Greater, Derby, and with the consents of John Henry Buxton, of Easeneye, Ware, in the County of Hertford, Esquire, of the Venerable Robert Charles Joynt, of Number 12, Kingswood Road, Norwood, in the County of Surrey, Archdeacon of Kingston-upon-Thames and a Canon of the Cathedral Church of Southwark, and of Sir Thomas Walker Hobart Inskip, Your Majesty's Solicitor General (commonly known as the Patronage Trustees of the Church Pastoral Aid Society) as the Patrons of the Vicarage of the said Parish of Normanton (in testimony whereof they, the said consenting parties, have respectively signed and sealed this Representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would in our opinion, be expedient that all those contiguous portions of the said Parish of Osmaston, of the said New Parish of Saint James the Greater, Derby, and of the said Parish of Normanton, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one Consolidated Chapelry for the said Church of Saint Bartholomew, Derby, situate as aforesaid, and that the same should be named ' The Consolidated Chapelry of Saint Bartholomew, Derby.'

[•] THE SCHEDULE to which the foregoing Representation has reference.

"I. All that portion of the Parish of Osmaston, in the County of Derby and in the Diocese of Derby, which is bounded upon the east by the Chapelries of Alvaston and Boulton, upon the south by the Extra Parochial Place called or known as Sinfin Moor, upon the west by the Parish of Normanton, upon the north west by the New Parish (sometime Particular District) of Saint James the Greater, Derby, all in the said County and Diocese, and upon the remaining side, that is to say, upon the north east, by an imaginary line commencing at the junction of Cotton Lane with Osmaston Road where the boundaries of the said New Parish of Saint James the Greater, Derby, the New Parish of Saint Andrew, Derby, in the said County and Diocese, and the said Parish of Osmaston all meet, and extending thence south eastward along the middle of Osmaston Road for a distance of 70 chains or thereabouts to the boundary which divides the said Parish of Osmaston from the said Chapelries of Alvaston and Boulton.

"II. Also all that contiguous portion of the said New Parish of Saint James the Greater, Derby, which is bounded upon all sides as follows, that is to say, upon part of the north west by the New Parish of Saint Thomas,
