#### ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 6TH JUNE, 1928.)

##### FOOT - AND - MOUTH DISEASE (INFECTED AREAS) ORDER OF 1928 (No. 54).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

##### *Further Contraction of Staffordshire Foot-and-Mouth Disease Infected Area.*

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 52) as amended by the Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 53) shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the Schedule to the last mentioned Order.

(2) This Article shall come into operation on the tenth day of June, nineteen hundred and twenty-eight.

##### *Release of Staffordshire Area from Restrictions.*

2. The Area described in the Schedule to this Order shall cease to be an Infected Area
