7. No person will be eligible who obtained from any tribunal established under the Military Service Acts, 1916 to 1918, exemption from service in His Majesty's Forces under those Acts on the ground of a conscientious objection to the undertaking of military service or, although not so exempted, declined to comply with obligations imposed upon him by those Acts.

8. Persons holding situations in the Civil Service must obtain the permission of the authorities of their Department to apply for

appointment.

No person actually serving in the Army, Navy or Air Force will be eligible for consideration unless he produces, when called upon to do so, the permission of his Commanding Officer to apply for appointment, dated before his appearance before the Selection Board, and given in accordance with such orders as may from time to time be issued.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate education authority has been notified to the Civil Service Commissioners.

- 9. The appointment of selected candidates will be subject to their satisfying the Civil Service Commissioners of their eligibility in respect of age, nationality, health and character, and will not be confirmed unless and until they have passed the prescribed period of probation to the satisfaction of the Department.
- 10. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons will disqualify them for appointment. The Selection Board will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work.
- 11. Candidates selected for appointment will be required to pay a fee of £8.
