Monck, may henceforth have, hold and enjoy the title, rank, place, preeminence and precedence as daughters of a Viscount which would have been due to them respectively had their father Charles Henry Stanley Monck (commonly called the Honourable Charles Henry Stanley Monck), Captain, Coldstream Guards, survived his father the late Henry Power Charles Stanley Viscount Monck, and thereby succeeded to the said title and dignity of Viscount Monck.

And to command that the said Royal Order and Declaration be registered in His Majesty's College of Arms.
