Stafford Street, and extending thence south westward along the middle of Stafford Street for a distance of 16<sup>1</sup>/<sub>4</sub> chains or thereabouts, to its junction with Suffolk Street, and continuing thence south westward in precisely the same direction and in a straight line for a distance of  $1\frac{1}{2}$  chains or thereabouts to the boundary which divides the said New Parish of Saint John, Chadderton, from the said New Parish of Christ Church, Chadderton."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have with the exception hereinafter mentioned respectively signified their assent thereto:

And whereas the Incumbent of the Vicarage of the New Parish of Saint John, Chadderton, has not signified his assent to the said Scheme or Representation:

And whereas a period of more than one calendar month has elapsed since drafts of the said Scheme or Representation were sent to the said Patrons and Incumbents:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Manchester.

## PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 12th day of July, 1928, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice ') of Tarrant Rushton with Tarrant Rawston, in the County of Dorset and in the Diocese of Salisbury:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Tarrant Rushton with Tarrant Rawston is vested for an estate in fee simple without incumbrances in the Reverend Edwin Allwright of the Rectory, Tarrant Rushton, Clerk in Holy Orders:

"And whereas the said Edwin Allwright is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Tarrant Rushton with Tarrant Rawston now vested in him as aforesaid, should be transferred to and be vested in the Bishop of Salisbury for the time being:

"And whereas the Right Reverend St. Clair George Alfred, now Bishop of Salisbury, is willing to accept such transfer and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said St. Clair George Alfred, Bishop of Salisbury, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Tarrant Rushton with Tarrant Rawston which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Tarrant Rushton with Tarrant Rawston:

"Now, therefore, with the consent of the said Edwin Allwright (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said St. Clair George Alfred, Bishop of Salisbury (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Tarrant Rushton with Tarrant Rawston now vested in him, the said Edwin Allwright as aforesaid, shall be transferred to the said St. Clair George Alfred, Bishop of Salisbury and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said St. Clair George Alfred, Bishop of Salisbury, and by his successors in the same Bishopric for ever.
