WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 12th day of July, 1928, in the words and figures following, that is to say:— "We, the Ecclesiastical Commissioners for

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Churches and Cures (hereinafter called ' the said Benefices ') of Great Malvern and the Holy Trinity, Great Malvern, both in the County of Worcester and in the Diocese of Worcester:

"Whereas the Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Great Malvern and the Holy Trinity, Great Malvern, is vested for an estate in fee simple without incumbrances in the Right Reverend Ernest, Bishop of Worcester, in his private capacity, and John Stallard, of the City of Worcester, Solicitor:

"And whereas the said Ernest, Bishop of Worcester, and John Stallard are desirous that the whole Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Great Malvern and the Holy Trinity, Great Malvern, now vested in them as aforesaid, should be transferred to and be vested in the Bishop of Worcester for the time being:

"And whereas the said Ernest, Bishop of Worcester, has executed this Scheme as hereinafter mentioned not only in token of such his desire but also in token of his willingness as such Bishop to accept such transfer and in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary:

"And whereas the transfer of the Patronage of the said Benefices of Great Malvern and the Holy Trinity, Great Malvern, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parishes or Districts in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Great Malvern and in the New Parish of the Holy Trinity, Great Malvern:

" Now, therefore, with the consent of the said Ernest, Bishop of Worcester (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal) and with the consent of the said John Stallard (in testimony whereof he has signed and sealed this Scheme) we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and pre-sentation to each of the said Benefices of Great Malvern and the Holy 'Trinity, Great Malvern, now vested in them the said Ernest, Bishop of Worcester (in his private capacity), and John Stallard, as aforesaid, shall be transferred to the said Ernest, Bishop of Worcester. and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Ernest, Bishop of Worcester, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."
