PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

By an Order dated the 13th day of July 1928, the Minister of Health has declared that, on and after the 30th day of July 1928, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Berkhamsted, namely:—

Section 25 (which relates to the paving of yards in connection with dwellinghouses), and

Section 50 (which relates to the provision of an ambulance).

The above provisions are declared to be in force subject, as regards Section 25, to the conditions specified in the Order.
