## ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 22ND SEPTEMBER, 1928.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

- 1. Notwithstanding anything contained in Chapter 6 (Protection of Animals) of the Foreign Animals Order of 1910, and in Part VII (Protection of Animals) of the Importation of Canadian Cattle Order of 1923, animals shall not be carried on a weather deck of any vessel of the flush or spar deck type unless such deck is completely covered in to the satisfaction of the Minister.
- 2. This Order shall come into operation on the first day of November, nineteen hundred and twenty-eight, and shall cease to operate on the first day of April, nineteen hundred and twenty-nine.

3. This Order shall be read with the Orders mentioned in Article 1 hereof.
