

## WORKMEN'S COMPENSATION ACT, 1925.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made Orders authorising the employment on two day-shifts, of (1) women of 18 and young persons of 16 years of age and over in cleaning, polishing, and examining nozzles used in spinning viscose in the Instrument Department, and (2) women of 18 years of age and over in cleaning workrooms and attending cloakrooms, at the works of The British Enka Artificial Silk Co. Ltd., Aintree, Liverpool. The Orders are made subject to the conditions that suitable protective clothing shall be provided for the women and young persons employed in the Instrument Department; that a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation, washing facilities and facilities for sitting shall be provided, and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
