#### Civil Service Commission, October 16, 1928.

The Civil Service Commissioners hereby give notice that, with the approval of the Lords Commissioners of His Majesty's Treasury, the following situations in the Civil Service have been added to the Schedule appended to the Order in Council of the 22nd July, 1920, namely:-

- (a) All situations in which it may become necessary, in order to meet a special emergency, temporarily to employ persons who have not been certificated by the Civil Service Commissioners, provided that such employment has the previous approval of the Treasury, and that its duration does not exceed twelve months, or such extended period as the Treasury may in each case approve.
- (b) Persons temporarily engaged under arrangements sanctioned by the Treasury, in the employment of the Head of a Department, and paid out of a lump sum assigned to him for the purpose.

(c) Commissionaires employed by Government Departments.

- (d) Unestablished Messengers (including those belonging to the permanent unestablished class).
- (e) Unestablished Paper Keepers or Press Keepers (including those belonging to the permanent unestablished class).

(f) Cleaners, Porters, Coalporters and Firelighters.

(g) Charwomen.(h) Unestablished Cloakroom and Lavatory Attendants.

(i) Temporary Clerks.

- (j) Clerks belonging to the permanent unestablished class.
- (k) Temporary Typists Shorthand orTypists.

(1) Unestablished Operators of Tabulating Machines or Duplicators.

(m) Telephone Operators (when they are blind persons).

## ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 15TH OCTOBER, 1928.)

FOOT - AND - MOUTH DISEASE (IN-FECTED AREAS) ORDER OF 1928 (No. 64).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

### Further Contraction of Yorks (East Riding) Foot-and-Mouth Disease Infected Area.

- 1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 60) as amended by the Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 61) shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the Schedule to the last mentioned Order.
- (2) This Article shall come into operation on the twenty-first day of October, nineteen hundred and twenty-eight.

## Release of Yorks (East Riding) Area from Restrictions.

2. The Area described in the Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the twenty-eighth day of October, nineteen hundred and twenty-eight.

### Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1928 (No. 64).
