# ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

### (Dated 19th October, 1928.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:--

And whereas by an Order by the Home Office under Section 26 of the London Government Act, 1899, and Section 2 of the Borough Collectors (Alteration of Number) Act, 1925, certain alterations will be effected in the constitution of Wards comprising the Metropolitan Borough and Civil Parish of Lewisham as from the 1st November, 1928.

And whereas it is expedient that corresponding alterations should be made in the constitution of the Registration Sub-districts hereinafter mentioned.

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1926, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Lewisham (Alteration of Sub-districts) Order, 1928, and shall come into operation on the 1st day of November, 1928.

2. In this Order the expression "Ward" means a Ward of the Metropolitan Borough of Lewisham.

3. The parts of Downham Ward, Hither Green Ward and Lewisham Park Ward which by the above recited Order will form part of the Lee Sub-district of Lewisham Registration District shall be transferred to the Catford Sub-district of the same Registration District.

4. The parts of Manor Ward and South Ward which by the above recited Order will form part of the Catford Sub-district of Lewisham Registration District shall be transferred to the Lee Sub-district of the same Registration District.

5. The part of Brockley Ward which by the above recited Order will form part of the Catford Sub-district of Lewisham Registration District shall be transferred to the Sydenham Sub-district of the same Registration District.

6. The Registrars of the existing subdistricts of Catford, Lee and Sydenham shall be respectively the Registrars of those subdistricts as altered by this Order.

### ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

#### (Dated 19th October, 1928.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1926, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Wilton Registration of Births, &c. (Alteration of Sub-districts) Order, 1928, and shall come into operation on the 1st November, 1928.

2. The existing Bishopstone Sub-district of Wilton Registration District shall be extended by the addition of the Wilton Subdistrict of the same Registration District, and the extended Sub-district shall be known by the name of the Wilton Sub-district.

3. The Registrar of the existing Bishopstone Sub-district shall be the Registrar of the Wilton Sub-district constituted by this Order.
