"3. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Much Cowarne shall become and be the house of residence for the Incumbent of the United Benefice.

4. That after the said union has taken effect the course and succession in which the respective Patrons shall present or nominate to the United Benefice from time to time as the same shall become vacant shall be as follows, that is to say, the first turn of presentation or nomination to be made to the United Benefice after the union shall belong to the Patrons of the said Benefice of Moreton Jeffries and the second and every subsequent turn of presentation or nomination thereto shall belong wholly to the Patron of the said Benefice of Much Cowarne.

"5. That with the consent of the said Martin Linton, Bishop of Hereford (testified as aforesaid), as Patron of the said Benefice of Avenbury, and with the consent of the Reverend Edward Henry Archer Shepherd, now Incumbent of the said Benefice of Avenbury (testified by his signing this Scheme), upon the union taking effect all those two detached portions of the said Parish of Much Cowarne situate in the Civil Parish of Stoke Lacy and lying to the east of the stream flowing from Hopton Dingle to the River Lodon, which said detached portions are more particularly delineated and set forth upon the Map or Plan annexed hereto and thereon coloured pink, shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Avenbury.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England,

or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Hereford has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be

effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Hereford.

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 11th day of October, 1928, in the words and figures following, that is to say: -

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being a Rectory) of Howick and the Benefice (being a Vicarage) of Long Houghton, both of which Benefices are situate in the County of Northumberland and in the Diocese of Newcastle:

"Whereas Commissioners appointed at our request by the Right Reverend Harold Ernest, Bishop of Newcastle, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union( of the said two Benefices of Howick and Long Houghton duly made their Report to the said Bishop of Newcastle and therein recommended the union of the said two Benefices and the Bishop of Newcastle signified in writing his approval of the said Report: terms for effecting the union, and the said

And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the

said Report:

"And whereas the said Benefice of Long Houghton is now full the Reverend Henry Burgh Dolland being the present Incumbent thereof and the said Benefice of Howick is at present vacant:

"And whereas the said Henry Burgh Dolland has consented to become the first Incumbent of the United Benefice, if and when the union which is hereinafter recommended and

proposed shall take effect:
"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Harold Ernest, Bishop of Newcastle (in testimony whereof he has signed this Scheme), do humbly recommend and propose to

Your Majesty as follows, that is to say:—
"1. That the said Benefice of Howick and the said Benefice of Long Houghton shall be permanently united together and form one Benefice with Cure of Souls under the style of The United Benefice of Long Houghton with Howick' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. That upon the day when any Order of Your Majesty in Council ratifying this Scheme
