The Civil Service Commissioners hereby give notice that an Open Competitive Examination for situations as Officer of Customs and Excise (Male) under the Board of Customs and Excise will be held, commencing on the 12th March, 1929, under the Regulations dated the 29th December, 1925, and published in the London Gazette of the same date; the first part of the examination will be held in Aberdeen, Belfast, Birmingham, Bristol, Cardiff, Edinburgh, Glasgow, Leeds, Liverpool, London, Manchester, Newcastle-on-Tyne, Plymouth and Portsmouth.

GUILDFORD.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Guildford (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Guildford Corporation Act, 1926, so as:—

(1) To enable the Corporation to make byelaws providing for the deposit of drawings of the elevations and particulars as to the materials (hereinafter called collectively "elevations") by persons intending to construct within the borough

(a) a building (including the reconstruction of an existing building); or

(b) an addition to an existing building (including the reconstruction of an existing addition to any such building); or

(c) a chimney exceeding forty-five feet from the ground in height;

(2) To provide that where elevations are required to be deposited by byelaws as aforesaid the Corporation shall within one month

(a) approve the elevations; or

(b) if they shall consider that the proposed building or addition or chimney would seriously disfigure the borough refer the question of the approval of the elevations to an advisory committee to be constituted for the purpose;

(3) For the purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that H. A. de Montmorency, Esquire, O.B.E., one of the Inspectors of the Ministry of Health will attend at the Town Hall, Guildford, on Tuesday, the thirteenth day of November, 1928, at eleven o'clock in the forenoon, to hold a Local Inquiry into the subject-matter of the said Application and the proposed Provisional Order.

And notice is hereby further given that any person interested may attend at such Inquiry and be heard with reference to the said Application and the proposed Provisional Order.
