

Continuance Bill now before Parliament, the increased maximum charges in respect of the Harbour Undertaking of the Port of Ramsgate, authorised by the Ramsgate Harbour (Temporary Increase of Charges) Order, 1927, should be continued after the 31st December, 1928.

Information as to the permanent statutory maximum charges in respect of the undertaking and the present increased maximum charges which it is proposed to continue may be obtained from the Harbour Master, Ramsgate Harbour.

### ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 13TH NOVEMBER, 1928.)

#### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1928 (No. 74).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

##### *Contraction of Bridport (Dorset) Infected Area.*

1.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 70) shall be read and have effect as if the Area described in the First Schedule to this Order were substituted for the Infected Area described in the Schedule to that Order.

(2) This Article shall come into operation on the nineteenth day of November, nineteen hundred and twenty-eight.

##### *Contraction of Blandford (Dorset) Infected Area.*

2.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 71) shall be read and have effect as if the Area described in the Second Schedule to this Order were substituted for the Infected Area described in the Schedule to that Order.

(2) This Article shall come into operation on the nineteenth day of November, nineteen hundred and twenty-eight.

##### *Further Contraction of Crewe (Cheshire) Foot-and-Mouth Disease Infected Area.*

3.—(1) The Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 67) as amended by the Foot-and-Mouth Disease (Infected Areas) Order of 1928 (No. 72) shall be read and have effect as if the Area described in the Third Schedule to this Order were substituted for the Foot-and-Mouth Disease Infected Area described in the First Schedule to the last mentioned Order.

(2) This Article shall come into operation on the seventeenth day of November, nineteen hundred and twenty-eight.

##### *Release of Crewe (Cheshire) Area from Restrictions.*

4. The Area described in the Third Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, as from the twenty-fourth day of November, nineteen hundred and twenty-eight.

##### *Short Title.*

5. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1928 (No. 74).

#### FIRST SCHEDULE.

An Area comprising:—

*In the county of Dorset.*

The borough of Bridport; and the parishes of Stanton St. Gabriel, Catherston Leweston, Whitchurch Canoncorum, Marshwood, Netherbury, Lodders, Shipton Gorge, Burton Bradstock, Swyre, Bothenhampton, Bradpole, Allington, Symondsbury and Chideock.

#### SECOND SCHEDULE.

An Area comprising:—

*In the county of Dorset.*

The borough of Blandford Forum;

The parishes of Pamphill, Hinton Parva, Hinton Martell, Chalbury, Gussage All Saints, Handley, Gussage St. Michael, Long Crichel, More Crichel, Witchampton, Shapwick, Tarrant Crawford, Tarrant Rushton, Farnham, Chettle, Tarrant Hinton, Tarrant Launceston, Tarrant Monkton, Tarrant Rawston, Tarrant Keynston, Tarrant Gunville, Steepleton Iwerne, Stourpaine and Pimperne; and so much of the parishes of Blandford St. Mary, Langton Long Blandford, Charlton Marshal and Spettisbury as lies to the east of the railway from Blandford to Bailey Gate Station.

#### THIRD SCHEDULE.

An Area comprising:—

*In the county of Cheshire.*

The borough of Crewe;

The parish of Church Coppenhall, and so much of the parishes of Leighton, Woolstanwood, Wistaston, Shavington cum Gresty, Crewe and Haslington as lies within the following boundary, namely:—

Commencing at the point where the road to Haslington leaves the southern boundary of the parish of Crewe near Philip's Hill, thence following that road in a generally northerly direction via Slaughter Hill Bridge and Slaughter Hill, and continuing thence through High Street, Haslington as far as Maw Lane; thence along that lane to the point where it crosses the eastern boundary of Church Coppenhall parish; thence northerly and then westerly along that parish boundary and the northern boundary of Leighton parish to the
