

"And whereas it has been proposed to us by the said Corporation and the said Arthur Foley, Bishop of London, that in order to render legally practicable an apportionment of the endowments of the said Benefice of Saint Peter upon Cornhill in favour of the said Benefices of Saint John the Evangelist, Brownswood Park; All Saints with Saint Olave, Mile End New Town; Saint Luke, Mile End Old Town; All Saints, Stoke Newington; and Saint Faith, Stoke Newington, the transfer of Patronage hereinafter recommended and proposed should be effected:

"And whereas it has been made to appear to us that such transfer of Patronage as is hereinbefore mentioned is expedient and will tend to make better provision for the cure of souls in the Parishes or Districts in or in respect of which the rights of Patronage or Advowsons so recommended and proposed to be transferred as aforesaid arise or exist, that is to say, in the New Parish of Saint John the Evangelist, Brownswood Park; the New Parishes of All Saints and Saint Olave, Mile End New Town; the New Parish of Saint Luke, Mile End Old Town; the New Parish of All Saints, Stoke Newington; and the New Parish of Saint Faith, Stoke Newington:

"Now, therefore, with the consent of the said Corporation (in testimony of which consent they the said Corporation have sealed this Scheme with their common seal) and with the consent of the said Arthur Foley, Bishop of London (in testimony whereof he has signed this Scheme and sealed the same with his episcopal seal), and also with the consent of the Right Honourable and Most Reverend Randall Thomas, Archbishop of Canterbury (in testimony of which consent he the said Archbishop has signed this Scheme and sealed the same with his Archiepiscopal seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to each of the said Benefices of Saint John the Evangelist, Brownswood Park; All Saints with Saint Olave, Mile End New Town; Saint Luke, Mile End Old Town; All Saints, Stoke Newington; and Saint Faith, Stoke Newington, shall be transferred from the said Arthur Foley, Bishop of London, in whom as such Bishop the same Advowson or perpetual right of Patronage and presentation is now vested as aforesaid, and from his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be fully and freely exercised by the said Corporation and their successors for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 8th day of November, 1928, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of the Benefice (being a Vicarage) of Droitwich, Saint Peter, and the Benefice (being a Rectory) of Droitwich, Saint Nicholas, both of which Benefices are situate in the County of Worcester, and in the Diocese of Worcester:

"Whereas Commissioners appointed at our request by the Right Reverend Ernest, Bishop of Worcester, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the union of the said two Benefices of Droitwich, Saint Peter, and Droitwich, Saint Nicholas, duly made their Report to the said Bishop of Worcester and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Worcester signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

"And whereas both of the said Benefices of Droitwich, Saint Peter, and Droitwich, Saint Nicholas, are at present vacant:

"And whereas the Advowson or perpetual right of Patronage of and presentation to each of the said two Benefices of Droitwich, Saint Peter, and Droitwich, Saint Nicholas, now belongs to one and the same Patron:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Ernest, Bishop of Worcester (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Droitwich, Saint Peter, and the said Benefice of Droitwich, Saint Nicholas, shall be permanently united together and form one Benefice with
