#### CROWBOROUGH DISTRICT WATER.

NOTICE is hereby given that application is intended to be made to Parliament in the Session 1928-9 by the Crowborough District Water Company (hereinafter referred to as "the Company") for leave to introduce a Bill (hereinafter referred to as "the Bill") of which the principal subject matters are as follows:—

Construction of new waterworks in the County of Sussex; pumping station and well in the Parish of Withyham in the Rural District of East Grinstead; service reservoir in the Parish of Wadhurst in the Rural District of Ticehurst.

Confirmation of existing works in the County of Sussex; extension of existing pumping station (Work No. 1) authorised by the Crowborough District Water Act 1899 such extension being in and under lands situate in the Parish of Crowborough in the Rural District of Uckfield; pumping station and well situate in the Parish of Rotherfield in the said Rural District of Uckfield; intercepting conduit collecting tanks wells bore holes and pumping station situate in the said Parish of Rotherfield and line of pipes situate partly in that Parish and partly in the said Parish of Crowborough upon land held under Lease from the Marquess of Abergavenny; Confirmation of rights of taking and intercepting water granted by the above-mentioned lease.

Construction of works subsidiary to new and existing works; breaking up of roads; discharge of water from waterworks; abstraction of water by new works and existing works; appropriation of lands and additional powers of acquiring land and easements by agreement; extension of powers of Section 12 of the Waterworks Clauses Act 1847.

Power to affix meters stop cocks and other apparatus on mains and pipes for preventing and detecting waste and to break up streets and roads for that purpose; power to break up private streets for supplying water to premises abutting thereon; amendment of Section 35 of Waterworks Clauses Act 1847; revision and alteration of rates for supply of water for domestic purposes and for purposes other than domestic; increased or additional charges or supply by meter where water supplied for domestic purposes is used for washing horses carriages or motor cars or other purposes or for or in connection with the working of refrigerators; supply by meter to dwelling-houses of which part is used for trade or manufacturing purposes and to certain other buildings institutions and premises; provisions as to supply of water for farming purposes; power by agreement to supply water for any purpose by measure; agreements for purchase of water in bulk; guarantees by urban and rural district councils in connection with extension of water mains and power to such councils to incur expenditure and to raise money; provisions as to notices of connecting or disconnecting meters; extension of power to enter premises for certain purposes and amendment or alteration of provisions of Waterworks Clauses Acts in their application to the Company; exemption from distress &c. of fittings and apparatus let for hire; penalties for wilful or negligent shutting off and unauthorised turning on of sluices cocks valves &c.; provisions as to expense of maintenance and repair of pipe supplying several houses or parts of houses in the occupation of several persons; power to persons liable to maintain pipes or apparatus to open or break up any street or road for the purpose of repair and provisions as to agreements for the execution by the Company of works on behalf of such persons and as to recovery of expenses of the Company; power to Company to repair defective communication pipes and recover the expenses from the owner or occupier of the premises; exclusive execution by the Company of works for connecting communication pipes with mains; additional capital and borrowing powers; provisions as to mode of
