SUTTON DISTRICT WATERWORKS.

PPLICATION is intended to be made to Parliament in the ensuing Session by the Sutton District Water Company (hereinafter called "the Company") for an Act the principal subject matters of which are as follows:—

To convert consolidate or amalgamate all or some of the existing stocks or classes of

capital of the Company and to empower the Company to raise additional capital and borrow further moneys and to establish contingency and reserve funds to make provisions with respect to dividends the sale of securities the payment of underwriting and other commissions the minimum holdings of securities the allocation and application of funds revenues and profits and for subscriptions to institutions &c. and to benevolent and sick funds.

To make further provisions with reference to meetings, directors, auditors, the sealing of the register, the substitution of a card or other index for the stockholders address book and other administrative provisions.

To remove the limitation imposed by Section 10 of the Sutton District Waterworks Act 1921 on the abstraction of water by means of the well or wells and pumping station and other works authorised by that Act and to authorise the abstraction of increased quantities of water therefrom either without limitation or subject to such limitation as the Bill may provide.

To require the payment of water rates in advance, to make provision in regard to the supply of water to caravans shacks huts tents and other like structures, the supply by measure to certain classes of buildings institutions and premises and for certain purposes, to authorise special or increased charges for water used in any such buildings and premises and in stables garages &c. and for or in connection with refrigerating apparatus or other special purposes and to provide that the Company may in certain cases require water to be taken and paid for by measure.

To empower district councils to enter into guarantees and contracts.

Provisions as to mains communication and service pipes, the provision of separate pipes and the maintenance of common pipes and obligations on owners lessees and occupiers, exempting fittings from distress, register of meters and other instruments, penalties for injuring meters or other instruments pipes or fittings or opening valves or other apparatus, entry into and inspection of consumers' premises, byelaws for preventing waste &c. of water, and to require the provision of cisterns for high level supplies.

Acquisition of lands &c. by agreement, agreements with owners lessees and occupiers and exercise of powers for drainage of lands and preservation of purity of water which Company are or may be authorised to take and appropriate and power to retain hold and use or sell lease exchange and dispose of lands.
